Position: Match Support Specialist Aide

**Description**: Interns will be working alongside the case managers (Match Support Specialists) to enroll volunteers and clients, assist in taking referrals, brainstorming virtual events for match participation, and providing resources to families as they navigate life during the pandemic. Due to the COVID-19 pandemic, our site can work with a maximum of two students during the spring semester. ## **Community Regional Medical Center Child Life Internship**

Learning opportunity at Community Regional Medical Center in the Child Life program. This experience is designed as an introductory experience for individuals interested in pursuing a career in child life. Through experiential learning and observation of a Certified Child Life Specialists, students begin to increase their knowledge of basic child life skills related to play, developmental assessment, and integration of child life theory into interventions with infants, children, youth and families. Students will increase their comfort level by interacting with infants, children, youth, and families in a variety of hospital settings, including the pediatric intensive care unit and burn unit. Through these experiences, students will enhance their knowledge of the child life profession and investigate the process of applying child life and developmental theory to practice. Please visit the Child Life Council (<a href="www.childlife.org">www.childlife.org</a>) for more information about the child life profession

The course will be run as a child life practicum and meet all standards and requirements as outlined by the Association of Child Life Professionals.

#### Requirements:

- Applicants must be current Fresno State seniors who will enroll in the CFS193 course.
- Completion of 120 hours. Applicants will complete one weekly 8-hour shift for a minimum of 15 weeks in order to complete the required 120 hours. Shifts typically start between 7 and 8am and end between 3:30 and 4:30pm. Students will work the same hours as their supervising child life specialist. **Applicants must have at least two full weekdays available for scheduling purposes.** Applicants whose schedule is too limited will not be accommodated.
- Applicants should have prior experience working with children and should feel comfortable in a hospital environment. Applicants should be able to demonstrate a solid grasp of child development theory and a basic understanding of the field and purpose of child life.
- Proof of immunizations and flu shot will be mandatory for chosen students prior to their start date
- 2 step TB test to be completed at CRMC employee health (no charge to student)
- Proof of COVID vaccination or receive vaccination at CRMC vaccination clinic (no charge to student).
   \* The Covid vaccine is non-negotiable as a requirement at the site\*
- Chosen students will be required to complete a background check through the hospital, which has a nonrefundable \$35 fee.
- Students will be required to wear scrubs during their shifts and must purchase these out of pocket.
- Students will be fitted for an N95 mask (test to be completed at CRMC and identified mask to be provided for free at the beginning of each shift).

## Central California Legal Services (CCLS)

**Description of internship:** For over 50 years, CCLS has provided free civil legal services to low-income individuals in Fresno, Tulare, Kings, Merced, Mariposa and Tuolumne Counties—a region where intense poverty exists side by side with unparalleled wealth and abundance. We work to improve the wellbeing of the Valley's most vulnerable residents through systems-changing advocacy, client education, and legal work that meets individual clients' immediate needs. We also work closely with agencies and community organizations that share our commitment to support our clients in being their own agents of change.

CCLS regularly offers volunteer internships to undergraduate students through our Pro Bono Program (PBP). The mission of the CCLS Pro Bono Program is to improve the quality of life of low-income residents of the Central Valley by ensuring ready access to a panel of skilled volunteer attorneys to resolve serious legal problems. Interns will work with one of our substantive legal teams: Housing; Health; Family and Immigration; and Consumers, Seniors and Public Benefits.

Interns will work closely with our staff attorneys, paralegals, and legal secretaries on client-serving projects. Interns may work directly with CCLS clients, and may also work on outreach, legal clinics, research, and other important projects. CCLS' dual goals for internships are to provide a meaningful, hands-on experience, ideally in a client-serving role, that contributes to the success of CCLS' mission.

Start dates, end dates, and schedules are flexible. CCLS' physical offices are still closed to the general public and most CCLS employees are working remotely. For Spring 2022, all of our internships will be remote; Summer 2022 is undecided. Interns will use their own technology hardware to connect to CCLS through Amazon Workstations. Interns will be jointly supervised by substantive team members and PBP's staff attorney.

# Specific details about the internship:

The number of hours are flexible based upon the needs of the individual student and the substantive team or legal clinic they choose to volunteer with. No specific experience or skills are necessary. The number of internships available depends on the substantive teams' staffing needs and availability. Most likely, one or two internships will be available. Monthly legal clinics will be available to all students.

Under the direct supervision of the Intervention, Prevention and Supportive Service Director, volunteers/interns may assist with providing advocacy for families and individuals participating in IPSS projects, including: Domestic Violence Assistance Program, Rape Crisis Program, XC County Victim Services (Human Trafficking and Elder Abuse), HUD Housing Projects, and Cal Learn.

#### **Example of Duties**

- Interview families entering the BSWS to assess the level of family and individual functioning and make appropriate referrals to community agencies and organizations for support services.
- Assisting the Legal Advocates with Temporary Restraining Orders and court accompaniment.
- Assisting IPSS staff with outreach activities
- Assisting Cal Learn Case Managers with activities related to pregnant and parenting teenagers.
- Assisting HUD Case Managers with activities related to housing and homelessness.
- Provide assistance to "special needs" families requiring services, such as translation (English/Spanish), crisis counseling for families and individuals experiencing acute

domestic violence trauma, sexual assault, human trafficking, elder abuse, and teen parenting.

- Assists with developing individualized goal plans for each family or individual that includes specific goals, objectives, and action steps to be achieved over the short term.
- Assist with monitoring implementation of the family or individual goal plan through weekly meetings.
- Interprets and enforces applicable KCAO and IPSS policies, rules and regulations to clients.
- May assist with preparing and maintaining case records, reports and answering correspondence.
- May assist with providing direct services such as peer counseling, information and referrals, and advocacy as needed.
- May assist with answering crisis calls and helping client's access appropriate services.

# Knowledge to be gained through this internship:

Selected candidates will provide support in the coordination, implementation and evaluation of community health, wellness promotion, and family strengthening programs, while also gaining generalist experience in the field.

# **CFS 193I Research Internship Opportunities**

Research internship opportunities enable students to work closely with a faculty member to gain research skills and experience.

Research internships may be of interest to students who are considering graduate school, jobs in research, or faculty careers in junior colleges or universities, or to those who would like to build their understandings of research involving children or families.

# Research Assistantship Internship with Dr. Billen

Dr. Billen is seeking two (2) qualified interns to assist on a research project examining how family scientists have been measuring parenting in recent years. In this unpaid internship, students will work as research assistants (RA) and will be responsible for the following duties: learning about content analysis procedures; reading and coding empirical research articles; assisting in manuscript and conference submission preparation; and attending weekly research lab meetings (CFS 192). By participating in this internship, students will develop and improve their skills in research, writing, and collaboration. In addition, students will contribute to the field of family science by examining and evaluating research on parenting and offering recommendations for future research. The internship can flexibly be offered in-person and virtually and will account for 120 internship hours during the Spring 2022 semester.

Applicants must be interested in research on parenting and have a basic understanding of research methodology. Preference will be given to students who have passed CFS 153, CFS 135, and CFS 130W with an A or a B. In addition, students must be organized, reliable, conscientious, and enthusiastic about research.
